Adventures in TC Summer Childcare

It has been a fun-filled summer season at TC Summer Childcare! Some highlights of the summer fun have been visiting the Montcalm County Fair to see the animals and ride the rides, participating in four local library summer reading programs, visiting local parks and splash pads, and participating in daily crafts and learning activities at Tri County Elementary, which serves as our "home base" for the summer. Staff strives to facilitate learning through play, with a focus on students' social and emotional growth and STEM learning opportunities.

> The Montcalm County Fair was an instant hit with the kids and staff members alike! We hope that this becomes a new summer tradition for the program. Through our participation with Sand Lake (KDL) Library reading program, kids were able to earn free wristbands to go on the rides at the fair by reading and logging the books. Some fan favorites at the fair were the rock wall, the giant slides, and face painting.

Kids participated in the summer reading programs at the Timothy C. Hauenstein (Howard City), KDL (Sand Lake), Newaygo, and Grant public libraries. Many kids finished their summer reading logs for each program and earned prizes like free ice cream, new books to bring home, and small toys. Three of the four libraries also had summer celebrations to wrap up their summer programming, and we were thrilled to take the kids to participate in the fun!

> One of the favorite summer activities for our kids is "park hopping." We frequently visited Morley Park (Cedar Springs), Long Lake Park (Cedar Springs), Gordon Park (Sand Lake), the new Pierson Township Park, and Ensley Park (Howard City). The splash pads in Sparta and at the Spencer Township Park (Gowen) were also a hit! We love visiting parks because it gets the kids outside and encourages them to get active.

While "school" isn't the focus of our summer program, we do make sure to include plenty of learning opportunities for the kids! We use a STEM-centered curriculum (called World of Words) for short daily lessons. Several of

our students were also able to take advantage of the Camp TC summer programming offered by the school in June. We look forward to partnering with Camp TC more in the future to bring greater learning opportunities to our kids!

The new elementary school and its gorgeous playgrounds have been an amazing "home base" for our summer childcare kids. The central air means that kids are comfortable anywhere in the building. The well-equipped cafeteria and kitchen servery means the kids have many lunch options available each day. Having multiple rooms available in the same area of the school has meant that we have defined learning, rest, and play spaces.

We also offer before/after school care at the elementary school during the school year and are looking to extend those services to middle schoolers as well. Parent/UE Summer Verification Reminder

ATTENTION PARENTS! Summer is quickly passing by, and we want remind you of the importance of completing the Summer Verification for your enrolled students!

Tri County Area Schools strives to always have the most up to date information for students at all times. That's why ALL parents/guardians are asked annually to verify current student information online through ParentVUE. This information includes address, phone numbers, emergency contacts, health information, etc. Simply log into your ParentVUE account and you will be prompted to complete the "2024-2025 Back-to-School Summer Verification".

Please be aware that verifying all current student information through your ParentVUE account is vital, as this is required prior to having access to information regarding the new school year, such as teachers/homerooms, schedules, busing, etc.

If you have address changes and/or other busing changes, these need to be completed by **August 13th** in order for these changes to be implemented for bus routing for the new school year. Changes made after August 13th will not be initiated/approved until after school begins.

All-Sport Passes will be available for purchase beginning Monday, August 19th. Passes can be purchased from the high school office and at all home Varsity football games.

Ticket holders will be able to attend all high school and middle school events, with the exception of any state tournament events that Tri County might host.

Tri County Childcare

Tri County Childcare programs are now taking enrollments for before and/or after school care. Child Care is offered at Tri County Elementary and Tri County Middle School.

Monday through Friday

6:00 am until school starts /After school to 6:00 pm

AM - \$10 per session

PM - \$10 per session

One Session Family Discount - \$4.00 discount per additional child

Both Sessions - AM/PM same day - \$18 per day

Family Discount AM/PM same day - \$14 total cost for each additional child



School Delay Program Hours

When school has a delayed start before 6:00 a.m., TC Childcare will be open starting at 7:30 am to receive students. If delayed after 6:00 a.m. childcare will remain open until the start of school. This option is available even if you do not use TC Childcare on the regular basis. Parents wishing to use this service must have all required paperwork completed and on file prior to using this service. Cost for the School Delay Program is \$14.00 for one child.

Scheduled Early Release Program

TC Child Care will be running Early Release Day childcare for school aged children (5–12) at Tri County Elementary and Tri County Middle School during the school year, for each of the scheduled early release days. Parents will be required to register separately to attend this program. The cost for the program is \$26.00 for the 1st child, and \$22.00 per child for each additional child. Same Day (not pre-registered) service is available at a rate of \$30.00 for the 1st child, and \$26.00 for each additional child. (Must call first to check availability)

Free School Meals Continue at TC!

We are pleased to share that Tri County Area Schools is once again participating in the National School Lunch and Breakfast programs for the 2024-2025 school year. ALL TRI COUNTY AREA SCHOOL STUDENTS enrolled can receive a healthy breakfast and lunch everyday FREE OF CHARGE. This is a tremendous benefit for our Viking families.

EMERGENCY CLOSING INFORMATION

Inclement weather, hazardous road conditions, power outages or other incidents may require the closing of school. However, there are strict state requirements on the number of hours of education for public school students. The state provides up to 6 days for inclement weather/emergency closing. We are required to make up any additional hours. With student safety as our first priority, every effort is made to avoid school closings when possible.

Inclement Weather Guidelines

There are several principles that guide our decision-making with regard to school closings. First and foremost, is the safety of our students and staff. In bad weather, the decision to close school is made after:



- Weather conditions are examined (weather advisories, storm patterns, temperature, etc.),
- Montcalm County Road Commission's ability to plow area roads is determined, and
- The condition of school driveways and parking lots are assessed.

On days when inclement weather occurs, we try our best to make the call by 5:00 a.m. to provide as much time as possible for families to be notified so that arrangements may be made for childcare, etc. Once the decision is made to cancel school we inform parents via our robocall system, email, local TV stations, our website and Facebook/Instagram pages. You can also download the Tri County App to receive a push notification regarding closings.

Decisions regarding school closings due to snow and ice are made after TCAS transportation staff make a recommendation regarding the ability of our buses and drivers to safely conduct their routes. It is possible that main roads will be drivable while our many miles of unpaved roads are not. We will close school if the air temperature with wind chill is expected to be at or below -20 degrees Fahrenheit while students are waiting for the bus or walking to school. As always, we encourage our students to dress in layers to protect themselves from the cold.

Annual Legal Notices

Notice for Directory Information Disclosure

The Family Educational Rights and Privacy Act (FERPA), a Federal law, requires that **Tri County Area Schools (the "District")**, with certain exceptions, obtain your written consent prior to the disclosure of personally identifiable information from your child's education records. However, Tri County Area Schools may disclose appropriately designated "directory information" without written consent, unless you have advised the **District** to the contrary in accordance with District procedures. The primary purpose of directory information is to allow the District to include information from your child's education records in certain school publications. Examples include: A playbill, showing your student's role in a drama production; The annual yearbook; Honor roll or other recognition lists; Graduation programs; and Sports activity sheets, such as for wrestling, showing weight and height of team members.

Directory information, which is information that is generally not considered harmful or an invasion of privacy if released, can also be disclosed to outside organizations without a parent's prior written consent. Outside organizations include, but are not limited to, companies that manufacture class rings or publish yearbooks. In addition, two federal laws require local educational agencies (LEAs) receiving assistance under the Elementary and Secondary Education Act of 1965, as amended (ESEA) to provide military recruiters, upon request, with the following information – names, addresses and telephone listings – unless parents have advised the LEA that they do not want their student's information disclosed without their prior written consent. [Note: These laws are Section 9528 of the ESEA (20 U.S.C. § 7908) and 10 U.S.C. § 503(c).]

If you do not want Tri County Area Schools to disclose any or all of the types of information designated below as directory information from your child's education records without your prior written consent, you must notify the District in writing by September 15, 2023. For a list of information designated by Tri County Area Schools as directory information please visit www.tricountyschools.com.

Asbestos Management Program

This notice is to inform you that state-approved asbestos inspection and management plans exist for all buildings in the school district. These plans are in each building's main office and are available for review.

The management plan contains information regarding the location of all asbestos-containing materials, the condition of the material, and the specific location of any remaining materials.

Detailed re-inspections occur every three years and periodic surveillance is performed every six months. These inspections have confirmed that all known asbestos is properly sealed and has not deteriorated so as to cause a safety concern. Our treatment of remaining asbestos is in conformity with all Environmental Protection Agency guidelines.

Pesticide Control Act

State of Michigan law requires that schools that may apply pesticides on school property must provide an annual advisory to parents or guardians of students attending the facility.

Please be advised that the Tri County Area Schools utilizes all suitable techniques in total pest management with the intent of preventing pests from reaching unacceptable levels or to reduce an existing populations to an acceptable level. Pest management techniques emphasize sanitation, pest exclusion, and biological controls. One of the objectives is to reduce or eliminate the need for pesticides to be utilized.

As required by State of Michigan law, advance notice of the application of a pesticide, other than a bait or gel formulation, will be given 48 hours before the application. Please note that notification is not given for the use of sanitizer, germicides, disinfectants or anti-microbial cleaners. In certain emergencies, such as an infestation of stinging insects, pesticides may be applied without prior notice to prevent injury to students, but parents/guardians will be notified following any such application.

Advance notification of pesticide applications, other than listed above, will be given by using two methods. The first method required by law is the posting at entrances to your child's school. The second method we will use is the posting in a public common area of the school.

Parents are also entitled to received this notice by mail, post-marked 3 days before the application. If you would like to be notified by mail, please contact Thomas Phinney, Operations Director, at 616-636-5454.

Annual Education Reports

The Michigan Department of Education requires all schools to publish an annual report to inform the residents about the status of their schools. This report provides detailed information on student assessment results, Adequate Yearly Progress results, teacher qualification information, and the state results for the National Assessment of Educational Progress.

Right to Request Personal Curriculum

What is a personal curriculum?

The personal curriculum (PC) is a process to modify specific Michigan Merit Curriculum (MMC) high school credit requirements and/or content expectations based on the individual learning needs of a student. It is designed to serve students who want to accelerate or go beyond the MMC requirements and students who need to individualize learning requirements to meet the MMC requirements.

Who may request a personal curriculum?

- The parent or guardian of a student for whom a personal curriculum is sought
- The student, if the student is of the age of majority
- An emancipated minor
- A teacher who is currently teaching the student (who currently teaches in, or whose expertise is in, a subject area proposed to be modified by the PC, or who is determined by the principal to have qualifications otherwise relevant to developing a PC),
- A school counselor or school employee qualified to act in a counseling role.

When may a personal curriculum be requested? If the student has an Individualized Education Program

If the student has an Individualized Education Program (IEP), the personal curriculum request may be submitted prior to 9th grade, although any resulting PC may not be implemented until the onset of 9th grade. Tri County Upholds CIPA Policy

Tobacco Use/Products on School Grounds

For the purpose of this policy, "use of tobacco product" means any of the following: the carrying by a person of a lighted cigar, cigarette, pipe, or other lighted smoking devices; the inhaling or chewing of a tobacco product; the placing of a tobacco product within a person's mouth; and/or the smoking of electronic, "vapor," or other substitute forms of cigarettes, clove cigarettes or other lighted smoking devices for burning tobacco or any other substance.

Tobacco companies/products may not sponsor any school activity.
